

Which Visitor or International Employee needs to be approved through RAMP Export Control?

The following circumstances require approval through RAMP Export Control. Questions or comments should be addressed to research-compliance@fsu.edu.

SECTION 1	Ramp Type: <i>Visiting Scholar</i> <u>OR</u> <i>International Employee (on RAMP, Visa I 129 Part 6)</i>
<p>Regardless of department or job code:</p> <ul style="list-style-type: none">• Any individual located in a foreign country of concern (China, Cuba, Iran, North Korea, Russia, Syria, or Venezuela),• Any individual who is a member of a political party of a foreign country of concern, OR• Any U.S. citizen or permanent resident (green card holder) who has a year or more of employment or training in a foreign country of concern.	
SECTION 2	Ramp Type: <i>Visiting Scholar</i>
<p>All Visiting Scholars</p> <ul style="list-style-type: none">• Domestic/International• Paid/Unpaid• Short/Long-Term• Unpaid recent graduates with F-1 OPT or J-1 Academic Training	
<p>Visiting Scholar Definitions and Examples:</p> <ul style="list-style-type: none">❖ Unpaid Visiting Scholar—Invited by an FSU faculty member to come to FSU to collaborate on research, lecture, and/or observe for a time period. Unpaid VS receives no funds from FSU and shows home government, institution, company funding, scholarship or personal funding. Receives a VS courtesy appointment to have access to university resources. This includes US citizens and US permanent residents as well as international visitors. <p><i>Examples:</i></p> <ul style="list-style-type: none">• Faculty member on sabbatical from another university invited to FSU to collaborate on research for time period.• Researcher, faculty member or professional from international institution invited to participate in research project or observe at FSU for time period.• Recent graduate (FSU or other university) invited to further their research (unpaid). This allows recent graduates to avoid impacting Optional Practical Training or Academic Training options while looking for a regular position.• International undergraduate student coming as J-1 student intern for supervised research.• Unpaid postdoctoral scholars with support from home government, foundation, fellowship, etc.• A renowned subject area expert (i.e., professional dancer, artist, coach, writer) <ul style="list-style-type: none">❖ Paid Visiting Scholar—Invited by an FSU faculty member to come to FSU to collaborate on research, and/or observe (not identified through a search committee and not to fill any permanent, salaried FSU position) who will receive a part-time appointment from the FSU department. This appointment cannot be for more than half time, unless the researcher is an international undergraduate student coming from outside the U.S. (see example below). The minimum rate per hour must meet or exceed the rate for a comparable level of regular part-time appointment. This includes domestic as well as international. Local domestic hire (lives in the area and applies for a position at FSU WOULD NOT be a Visiting Scholar) <p><i>Examples:</i></p> <ul style="list-style-type: none">• Researcher invited by FSU faculty member to come to FSU to collaborate on research for a time period and will receive a part-time appointment.• International undergraduate researcher doing supervised research (J-1 student intern) must be paid for at least 32 hours per week, if appointed at FSU.• Researcher, post-doc, or lecturer receiving partial pay from a fellowship, scholarship, or home institution and partial pay from FSU.• Expert or professional invited to FSU receiving an honorarium or one-time pay if stay exceeds 14 days (use Short-term option under Visitor if stay is less than 14 days) <p>Note: FAMU employees and students who require a courtesy appointment at FSU are <u>not</u> considered Visiting Scholars. See Section 3 below for data entry requirements.</p>	

SECTION 3**Ramp Type: *International Employee (on RAMP, Visa I 129 Part 6)***

1. All H1B, O-1, E-3, and TN Sponsored Employees;
2. All J-1 Non-Students/Non-Visiting Scholars;
AND
3. All other international appointments (Paid/Unpaid) who:
 - a. reside in one of the departments shown in Appendix A and
 - b. will occupy one of the job classifications shown in Appendix B.

However, see Section 1 for exceptions.

International Employee Definition and Examples:

International hires who will receive an FSU sponsored visa such as an H1-B, O-1, E-3, TN, or J1. (Check with CGE to confirm that proposed appointment qualifies for visa sponsorship.) This category also includes full-time or part-time international employees who already have authorization to work in the US (e.g., F-1 OPT, other EAD) who will reside in a department shown in Appendix A and will occupy one of the Appendix B job classifications.

Examples:

- International who will be appointed to any faculty teaching or research position, if needing FSU sponsorship or in Appendix A department/Appendix B job classification
- International who will be appointed to a staff position (OPS, USPS, A&P), if sponsored by FSU for an H-1B, O-1, E-3, TN, J-1, or in Appendix A department/Appendix B job classification
- Postdoctoral scholar, if sponsored by FSU or in Appendix A department/Appendix B job classification
- Graduate Assistant (all J-1 plus those in other visa classifications in Appendix A departments)
- FSU international student in paid position (current students offered PT campus jobs) if J-1 or in Appendix A department/Appendix B job classification
- International unpaid researcher collaborating from abroad who needs courtesy appointment and is working with Appendix A department

This International Employee category should not be used for internationals being invited to FSU who will receive a part-time appointment from the department and do not currently have any work authorization. These individuals are included in the "Visitor" (Visiting Scholar/Paid) category.

Special Instructions for FAMU employees and students:

FAMU employees and students who require a courtesy appointment at FSU are not considered Visiting Scholars. RAMP EC approval using a Request Type of *Visa* is required for any FAMU employee or student who is not a US Citizen, and needs a courtesy appointment at FSU to access facilities.

On the RAMP EC request, please indicate that the applicant is a FAMU employee or student on the Basic Information Page, in Question 3, as shown below:
